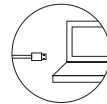
1. Unfold the supporting bracket of the webcam, and put the webcam at the top of the computer or monitor.

2. Press the supporting bracket against the reverse of the screen.



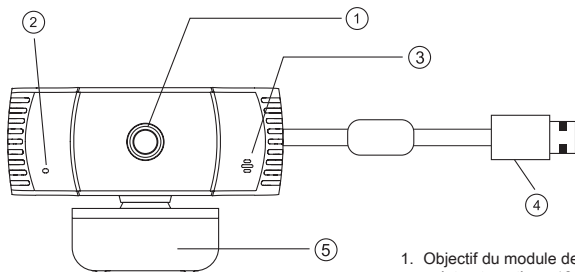
